It is one of the simplest and most meaningful ways to continue supporting the causes you care about beyond your lifetime.

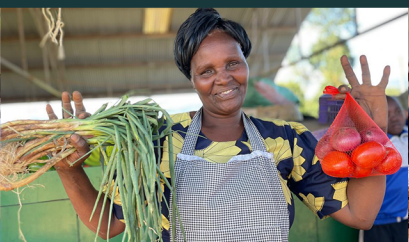
Legacy giving allows you to:
